# Terms & Conditions

## **Billing & Membership Terms**

- Memberships are billed monthly on the enrollment date
- Memberships automatically renew unless canceled in accordance with policy
- All payments are non-refundable

## **Commitment Requirements**

- Founding & Essential Memberships require a 3-month minimum commitment
- Elevated Membership requires a 6-month minimum commitment
- After the initial term, memberships continue on a month-to-month basis

## **Session Usage**

- Sessions must be used within the active billing cycle
- Unused sessions do not roll over
- Sessions expire at the end of each billing period
- Sessions are non-transferable

## **Appointment & Cancellation Policy**

- A minimum of 24 hours' notice is required to cancel or reschedule
- Late cancellations or missed appointments will result in a loss of session OR a charge equal to the service value

## **Membership Cancellation**

- A minimum of 30 days written notice is required to cancel
- Membership remains active during the notice period
- No refunds will be issued for unused sessions or partial billing cycles

## **Payment Policy**

- Membership access will be suspended for insufficient funds or declined payments
- Services may not be used until the account is brought current

## **Complimentary Birthday Session**

- Enjoy a complimentary birthday service—your choice of one core service or one injection.

## **Guest Policy (Elevated Membership Only)**

- Bring-a-friend benefit is limited to core wellness services only
- Excludes IV therapy and all practitioner-led services
- Subject to scheduling availability
